GENERAL BUSINESS:

1. Public Works

CAO Collier advised Council that there were ongoing sewer issues on Eldon Street resulting from residents flushing swiffer pads causing a blockage. Office Staff sent a memo via mass email/social media advising these issues & items that cannot be flushed- hopefully this will resolve the issue. If the problem becomes a re-occurring matter the decision will be made regarding the option of smoke testing.

There have also been ongoing water issues on a property located on Eldon Street, the standpipe for that property was relocated years ago; however, they are now experiencing low water pressure & there were also reports that the neighboring property across the road has a water leak as well. The Public Works Employees are going to attempt to resolve the water leaks; if unable to fix the Town may have to look at the possibility of contracting companies to assist in repairing. CAO Collier to update Council when available.

CAO Collier received an inquiry from one of the Public Works Employees regarding permission for snowclearing the Public Works Employees driveways. Council discussed this matter & it was agreed that there was never any approval from Council for Public Works Employees to clear their driveways, the only approval given regarding the clearing of driveways was to cut out the Fire Department members driveways after all roads have been cleared.

CAO Collier to advise the Public Works Employees that the clearing of their driveways is not permitted & to provide a list of Fire Department members to them.

2. Fortune Arena

Arena Attendant Paul Tulk attended the Arena Operator's Training in St. John's on November 13, 2019 and met with CAO Collier regarding the specifics, Tulk felt it was important to forward the notes taken throughout the training to Council.

Arena Attendant Tulk noted the importance any new employees taking part in the Arena Operating Course.

Arena Attendant Tulk pointed out that in the Town of Fortune's helmet policy it stated that wearing a helmet while on the ice is mandatory; Tulk suggested using the words "STRONGLY ENCOURAGE" for the purpose of the Towns liability if helmets are not worn correctly.

Council agreed to continue the use of the word "MANDTORY".

The importance of the Carbon Monoxide Detectors was also discussed, CAO Collier advised that the Town was denied gas tax funding for the carbon monoxide detectors; however, she resubmitted the applications under "arena upgrades".
