"Council shall impose a business tax on any persons or companies carrying a business within a municipality. A council by resolution shall establish the rate for business tax whether it is based on the assessed value of the property or the gross revenue method. The assessed value method shall be applied where there is a fixed place of business and the town has imposed a property tax. Where a property tax has not been imposed or there is no fixed place of business the business tax rate is set as a percentage of the gross revenue. A council may impose different tax rates on different business types and may set a minimum business tax for each type of business".
