- 5. Arena Dressing Rooms- Received requests from United Towns Minor Hockey & Recreation Hockey requesting permission to utilize dressing rooms at the Fortune Arena. It was a consensus of Council to defer this discussion until the next Council Meeting to see the status of Covid-19 cases before making a decision.
- 6. Container OCI Property/Haddock Road Equipment- CAO Collier advised Council that the resident who had received approval to "temporarily" store the container on Town/OCI property have recently requested approval to place he container in the front of their property located on Bayview Street; meanwhile, there is still equipment left at the rear of their property which Council had asked to be removed a few years ago.

CAO Collier to contact property owner to advise Council is not in agreement to having the container placed anywhere within a residential area & in addition, advise of the concerns placed with respect to a piece of equipment (arm) located on the rear of their property.

7. Lighthouse Trail Development- Department of Natural Resources were receptive of the consideration to change the management place of Fortune Head Ecological Site. Natural Areas will conduct the GPS layer of the proposed trail; however, would require a representative of the Town to be present as well.
