Deputy Mayor Smith welcomed Fred Dodge & Rosalind Dodge to the Council Meeting. Mr. Dodge thanked Council for giving him the opportunity to meet to discuss the Town of Fortune's priorities should be become elected as MHA for the district. Mr. Dodge referenced issues such as the Fortune Arena, noting that it is a significant piece of infrastructure used for younger as well as older residents & to have the arena out of service for even part of the season isn't a good thing. If elected Mr. Dodge advised that he would do his utmost to try & secure funding where at all possible. Deputy Mayor Smith advised Mr. Dodge of the upcoming Downtown Development project including parking, lighting & some directional signage. Mr. Dodge noted that over the past sixteen years he has been in the parks/tourism sector, which is a great asset for the Town of Fortune in regards to the Downtown Development Project, Horsebrook Walking Trail, Fortune Head Ecological Reserve & Fortune Head Geology Centre. Mr. Dodge thanked Council for their time & left the Council Meeting at 6:46 p.m.

> Special Assistance Funding- CAO Collier advised Council that she had applied for Special Assistance Funding for the Arena Plate Exchanger/Brine System Flush based on the quote received from KeepCool in the amount of \$111,000, the Town of Fortune would be responsible for 40% of the cost (approximately \$44,450.72). Scotiabank to provide financing details & CAO Collier will provide as it comes available if that is the route Council's chooses to take. CAO Collier will advise when/if approval is granted for the Special Assistance Funding.

Roof Tenders- CAO Collier advised Arena Roof Replacements tenders are set to close on February 26 at 4:00 p.m. & scheduling for opening on March 1st at 8:00 a.m. & will require a Councillor present to open tenders. Councillor Kendell to attend.

It was questioned whether it was a requirement for the company/business submitting a tender to be COR certified, CAO Collier to get clarification & advise.

- Indoor Activities- CAO Collier advised Council that it was suggested by Arena Attendant Tulk the possibility of offering indoor activities in the Fortune Arena, i.e. ball hockey, walking, etc.
 - Council agreed it was a great idea, CAO Collier to reach out to user groups (i.e. Minor Hockey, Figure Skating, CYN, Recreation Commission & Senior's Club) to offer the opportunity to coordinate indoor activities at the Fortune Arena. It was agreed to wait until next week (February 15th) to see how the Covid situation is & send an email to user groups.
- Staffing- CAO Collier was wondering the options for Arena Attendant Tulk, normally he is hired for the Arena from January- April & October- December and with the Public Works Employees at the Town in May-September; however, with the closure of the arena & once the ice is removed, he will not need be needed in there.
 - Councillor Fleming advised CAO Collier there is a program where you can top up the employee's employment insurance, will forward details via email.
 - Council agreed for CAO Collier to check into the details of the program advised by Councillor Fleming & to schedule a Human Resources meeting for Monday for further discussion & CAO Collier to meet with Arena Attendant Tulk prior to the meeting.
- 2. <u>Memorial University Engineering Students</u> CAO Collier had recently sent this information to Councillor's prior to the Council Meeting; however, would like to have a motion documented

Memorial University, ACOA & Municipalities Newfoundland & Labrador are matching MUN Engineering students with municipalities. The program provides professional work experience for up to fifteen engineering students. Funding support from ACOA & MUN means the cost to municipalities is only 12.5% of the students salary, which is a maximum of \$25/hr.
