Fortune Fire Department-

Mayor Penwell welcomed Fire Chief Paul Peach, Deputy Fire Chief Charles Dominix, Firefighters Mark Collins, Terry Mullins & Kenneth Keeping to the Council Meeting. Council asked members from the Fire Department to attend the Council Meeting to discuss the cost of the new fire rescue truck, initially it was thought that the Town of Fortune's share was 10%, unfortunately; the Town of Fortune is responsible for 20% of the cost. The cost of the fire rescue vehicle is \$285,000, leaving the Town of Fortune responsible for approximately \$56,000, Council was seeking the amount the Fortune Fire Department were able to contribute.

The Fortune Fire Department were prepared to contribute 10% of the town's share, less the HST (approx \$5600).

Mayor Penwell advised that the Town of Fortune were prepared to pay & are comfortable with paying \$15,000-\$33,000, leaving \$15,000-\$18,000. The Fortune Fire Department has to fundraise for their contribution, they are already had a few car washes & are doing the bar service for the wedding taking place at the Fortune Arena on Saturday (Sept 14).

Deputy Mayor Smith made a suggestion to the Fortune Fire Department, apply for a lottery license & sell tickets for a "Dream Kitchen for Christmas", Deputy Mayor Smith volunteered to build & install kitchen cabinets, all the Fire Department would be responsible for would be to purchase the materials.

Council thanked the Fortune Fire Department for attending the Council Meeting & they left at 6:53 p.m.

Mayor Penwell welcomed Terry Mullins to the Council Meeting. Mr. Mullins asked Council about the Victoria Hall Museum, across from his company building, wondering if the Town of Fortune was willing to sell the building, as he is stuck for storage.

CAO Collier advised Council that this matter was on the agenda at a council meeting in January and it was supposed to be resurfaced in the Spring. Council discussed this matter & agreed that the Town of Fortune no longer has a use for the building since Brookside Shed was purchased, the power has been cut at the Victoria Hall Museum since Brookside Shed was purchased, therefore; there is no power there.

Council agreed to entertain selling the storage shed, formerly known as the Victoria Hall Museum. It was questioned whether the property had to go on tender, CAO Collier advised that as a public body all Town property has to be advertised.

Ouncil agreed to discuss the matter further & will report back to Mr. Mullins with the decision. Mr. Mullins thanked Council for their time & Mayor Penwell thanked Mr. Mullins for attending the Council Meeting and he left at 6:58 p.m.
