Delegate (cont'd): Mr. Mark Collins, Development at 97 Eldon Street, Low-Income Housing The timelines are important for his budget process with May 1st targeted for land excavation and preparation for cement. Sunset Crescent sewer hookup and water lines on Eldon Street were identified as per Public Works Supervisor Caines. The water line connection to main (believed to be 18 inches) is requirement of property owner in the amount of \$500 (normal service – 1 residence). Responsibility of sewer requires clarification. CAO suggested to follow-up as per research on past units (i.e. BDF properties), prior to identifying costs (including pipe, etc.); meanwhile, Mayor Hickman sought clarification with respect to highway crossing to which she was advised a permit from Department of Transportation and Works would be required. CAO suggested due to time constraints, that the details obtained would be communicated via email with Council and subsequent notification provided in an email to Mr. Collins once identified.

GENERAL BUSINESS (cont'd):

2. Accessibility Plan:

The most recent revisions were incorporated into a different format by Town Clerk Symes as a more attractive read. CAO advised this is a "living document" and can be amended once approved; nevertheless, it is felt the document is now ready for the remainder of Council to review and provide any feedback with the anticipated approval at the next regular meeting of Council.

Peddler's Tax Application: 3.

CAO advised Council that several individuals are complaining and inquiring about this tax which is referenced as Peddler's Tax; therefore, as per research about other municipalities and reference to "Peddler's Tax Application", it was suggested that perhaps the wording could be changed from Peddler to "Minimum Tax" (i.e. business). There was some debate pertaining to ability of enforcing this tax as well as the length of time this tax has been on the tax structure. The recent advertisement to advise residents of Council's intention to enforce this tax to suspected individuals has generated some local discussions and reference to this being a "new" tax. It was the consensus of Council to remain status quo (i.e. no change in reference or application; it will remain Peddler's).

Meeting with Town of Grand Bank (Collaboration Grant): 4.

The correspondence generated by Council has resulted in the Town of Grand Bank assigning three of its' Councillors as their sub-committee; however, the Fortune Town Council will remain as a unified Council with respect to meeting with the delegation from the Town of Grand Bank in efforts of identifying potential areas whereby a Collaborative Grant could providing funding for the benefit of both municipalities. Councillor Piercey revealed that CAO Fleming with Town of Grand Bank advised at the MNL Regional meeting held in Clarenville that he has already submitted an application. CAO suggested that this would not be the ideal process as per no official collaboration project has yet been discussed with both municipalities, and in the statement by CAO Fleming, CAO nor Councillor Piercey inquired as to the purpose of such application. As per review of Councillors' availability, April 8th at 2:30 p.m. was the preferred date to seek availability from the delegation with the Town of Grand Bank.

Request for Information: 5.

Mayor Hickman is seeking information for Travis Hillier which includes letters of support from Town of Fortune to Everwind and Terra Nova Hydrogren. CAO indicated she would engage our Town Clerk to pull this information from files; however, two letters of support were located and provided to Mayor Hickman. Subsequently, additional Minutes identifying the appointment of Mayor Hickman to the Energy Board would also be obtained and sent to Mayor Hickman as per her ongoing communication with Mr. Hillier (all of Council will be copied in this emailed information).

- 1. Old banners inquiry was regarding the old Fortune Minor Hockey / Grand Bank Minor Hockey banners, and the possibility of putting back up as per preservation of history. CAO indicated a section of the roof will need to be repaired (i.e. nail holes with Styrofoam) before anything goes up, but she will follow-up with Paul as Arena Supervisor to seek feedback.
- 2. <u>Scoreboard Bulb</u> The discussion revealed bulb replacement, but CAO with respect to responsibility as to users of this piece of equipment mainly being Minor Hockey and Rec League, and whether or not fundraising by the association would provide replacement. CAO will follow-up with Paul with respect to responsibility for replacing.
- 3. <u>Sound System Purchase</u> Several complaints pertaining to this sound system. CAO advised she has engaged Arena Supervisor to seek out possible replacements due to inability to provide adequate communication during events (i.e. public speeches, etc.).
- ➤ Eldon Street property demolition Councillor Rose inquired about the demolition of the Town's property on Eldon Street which was deferred from previous meetings; however, CAO advised Mr. Terry Boland had submitted a more attractive proposal for the demolition. Mr. Boland works away for employment, but upon Council's approval, CAO will reach out and meet with him to initiate this project / demolition.
