GENERAL BUSINESS:

1. Downtown Development-Road Closures: As previously discussed at the last Council Meeting after posting for the public's input on the downtown development the Town Office received inquiries regarding Temple Street.

Council had a discussion whether it would be better for traffic to go down Temple Street or come up Temple Street. It was a consensus of Council for Office Staff to reach out to the residents affected to get their opinion & bring back to the next Council Meeting.

CAO Collier had contacted Jody Brushett & Trevor Bungay from ACOA and advised that the Town of Fortune is now in the position for beautification. CAO Collier to schedule a conference call with Trevor Bungay/Jody Brushett & Council to discuss beautification and directional signage for Piercey Street, Harbour Drive & Community Street as Counil would like to have the signage implemented by July 1st.

It was agreed to mail out the street signage & development proposal once approved by ACOA.

2. Snook's Road Erosion: This matter was addressed last year and resident was advised to contact the Department of Environment. Resident has since made contact with the MHA's office who had contacted the Town Office for follow up.

CAO Collier advised Council that she had to contact Craig Moore regarding a different issue & had inquired about the erosion on Snook's Road. Mr. Moore was in the area and had inspected the area on Snook's Road in question & advised that there is a concern with the erosion & in his opinion felt that the Public Works Employees would be able to complete the job with the exception of renting an excavator.

3.
