### 1. Downtown Development-

- a) Slipway- CAO Collier, Deputy Mayor Smith & Councillor Woodland met with Earl Rose from the Port Corporation and Mr. Rose had provided an overview regarding the slipway, at any given time 4-6 feet of water by the slipway and it will be located where the floating docks are now. They're hoping to have everything in place by June 2020.
- b) Frank's Lane-CAO Collier, Deputy Mayor Smith, Councillor Woodland and Mr. Earl Rose are suggesting to start the re-routing of traffic by February so that residents could get used to the flow of traffic before June. The Port Authority will be taking the responsibility of the signage, however; they will be getting approval from Council on the type of signage.

Council discussed the possibility of turning the Community Street/Piercey Street intersection into a four way stop as it was suggested at the meeting with Mr. Earl Rose as well.

It was also discussed at the meeting with Mr. Rose the possibility of shutting off Frank Lane's & turning in into additional parking for Collins'/waterfront, blocking off the road with a 7-8 ft wall, Mark Collins of Collins' Cloverfarm did show interest into helping towards the cost of paving for this specific area for additional parking.
