GENERAL BUSINESS:

1. Non Compliance Revocation/Overnight Parking:

After Privileged Meeting of Council, consultation with Municipal Affairs, subsequent emails and meetings with residents impacted or concerned with this parking arrangement it was a consensus of Council to allow overnight parking at 14-18 Bayview Street for an interim period (March of 2023) & revoke the Non Compliance Fee that was issued.

The approval of overnight parking will be a temporary arrangement and an additional submission for parking development at this and any other locations must be provided to Council before the Spring of 2023.

As CAO Collier was not in attendance during the Special Meeting of Council or aware of the reasoning and change in decision by Council she expressed her inability to correspond and suggested for Town Clerk Symes to draft correspondence in Consultation with Mayor Hickman to both parties affected.

2. George & Mary Lake House: The George & Mary Lake House is currently under Town of Fortune/Fortune Heritage, as the ortune Heritage Committee is dissolving there was an agreement from previous years that the property to be transferred back to the family once no longer wanted by the Town/Heritage Committee. CAO Collier advised Council that she is strongly encouraging legal counsel to complete the transfer.

It was a consensus of Council for CAO Collier to seek legal advice regarding the transfer of the George & Mary Lake house.

- 3. GBFA Accounting: CAO Collier advised Council that Byron Smith Accounting is scheduled to come to the Town Office for a training session on November 23rd & November 24th.
- 4. Harbour Drive Driveway Issue: Received correspondence from engineer at Innovative NL after final site visit that it is their opinion that this matter is a homeowner issue. Since the road had been paved before the driveway was installed, it is the responsibility of the homeowner to ensure correct grading of the driveway so that it ties in with the road properly. The simplest solution would be the homeowner redoing the driveway with proper grading at their own expense.

CAO Collier to send correspondence to Mrs. Carroll to advise.

5. Dixon Street Letter- Property Damage: Received correspondence from resident on Dixon Street regarding lawn damage from the garbage truck. Resident reached out to the Burin Peninsula Waste Disposal & was advised to contact Budgen's as they are the contractor. Resident attempted several times to have repairs initiated with Budgen's; however, with no success. Town Clerk Symes was made aware of the situation & has also reached out to the contractor with no success; therefore, correspondence was initiated by resident & sent to the Town for further review.

Councillor Kendell is a representative on the Burin Peninsula Regional Service Board & will raise this concern at the meeting scheduled for Wednesday, September 21st.
