GENERAL BUSINESS:

1. Port Corporation Taxes

Received correspondence from the Public Services & Procurement Canada regarding property 1650-325-1-1200 (Harbour Drive), according to the department the property was sold to Harbour Authority of Fortune and the deed was registered on March 19, 2012. Accordingly, it was no longer Federal property and therefore no longer PILT eligible as of that date. An overpayment was made to the Town of Fortune for 2012 & 2013 in the amount of \$6,809.72. This amount is outstanding to the Government of Canada and requires payment.

Council advised to give direction to CAO Collier to investigate further into this matter & to advise Public Services & Procurement Canada that the tax agreement between the Town of Fortune & the Fortune Port Corporation wasn't establish until 2014.

Resident Elieen Rose is being acknowledged for her volunteer service with the Canadian Cancer Society.
